# 1.2. <u>Executive Remit 2</u> – Constitution 1.A.1.1 – Capitations

# a) Existing Rule:

1.A.1.1 Capitations are those fees paid by an individual who has participated in target rifle shooting for a period in excess of six weeks in any capitation year, at a Club or Association affiliated to TSNZ. Payment of such Capitation Fees shall qualify an individual to become, or remain, an Ordinary Member of TSNZ.

# b) To be replaced with:

1.A.1.1 Capitations are those fees paid by an individual who has participated in target rifle shooting in any capitation year at a Club or Association affiliated to TSNZ. Payment of such Capitation Fees is required by all individuals who have shot at a TSNZ-affiliated Club or Association for a period in excess of six weeks, and shall qualify the individuals to become, or remain, an Ordinary Member of TSNZ.

# c) Explanation:

- 1. The existing rule is ambiguous.
- 2. Associations and Clubs have asked for clarification on the intent of this rule.

# 1.3. <u>Executive Remit 3:</u> Indoor Rules 2.1.5 – General

# a) Existing Rule:

2.1.5 Any person affiliated to TSNZ has the right to defer any matter, or appeal any local ruling, to the TSNZ Executive that shall be the sole arbiter on disputes and matters of interest. Appeals will be allowed by reasons of natural justice and interpretation of the intent of these rules.

# b) To be replaced with:

2.1.5 Any Ordinary Member of TSNZ has the right to refer any matter, or appeal any local ruling, to the TSNZ Executive, which shall be the final arbiter on disputes and matters of interest. These referrals or appeals will be considered by reasons of natural justice and interpretation of the intent of the TSNZ Indoor Rules, and must be received by the TSNZ Executive within 28 days of the matter occurring or receipt of the local ruling.

# c) Explanation:

- 1. The existing rule is ambiguous and can be interpreted to mean that further appeals are possible following the ruling of the TSNZ Executive, which is not the intention.
- 2. These changes bring this clause in line with the equivalent clause in the Outdoor Rules.
- 3. The time limit is in accordance with that of the Sports Tribunal of NZ and ensures matters are concluded in a timely fashion.

**Discussion:** Marlborough, East Otago, Graeme Hudson, Wellington, Mid Canterbury – regarding intent of new rule, appeals about Executive, national events, conflict of interest.

# 1.4. <u>Executive Remit 4:</u> Indoor Rules 2.4.9.1 - Gauges

# a) Existing Rule:

2.4.9.1 Certified gauges shall be:

a) wide flange type suitable for either the 18.288 meter (20 yards) or 22.860 meter (25 yards) standard targets and shall conform to the detailed dimensional drawing contained in Section 2, APPENDIX C.

b) a certified plug gauge with a diameter of 5.60mm (+0.00mm and -0.05mm), which may be used for testing all scoring rings but which must be used for testing the outermost scoring ring.

### b) To be replaced with:

2.4.9.1 TSNZ-approved gauges shall be:

a) a wide flange type suitable for either the 18.288 meter (20 yards) or 22.860 meter (25 yards) standard targets which shall conform to the detailed dimensional drawing contained in Section 2, APPENDIX C.

b) a plug gauge with a diameter of 5.60mm (+0.00mm and -0.05mm), which must only be used for testing the outermost scoring ring (i.e. testing between a score of 5 or 4).

### c) Explanation:

- 1. The plug gauge is only to be used for testing the outermost ring, therefore the statement that it may be used for testing all scoring rings is inaccurate and needs to be deleted.
- 2. Using the word "certified" indicates the gauge has either been manufactured by an accredited facility and a certificate of compliance is issued, or it has been inspected and certified by qualified personnel that it complies with the standard required by TSNZ. The new terminology more accurately describes the actual situation that the gauges are produced by a manufacturer approved by TSNZ to drawings and standards approved by TSNZ.

**Discussion:** Marlborough, Mid Canterbury, Southland, East Otago – regarding correct wording, testing process, modification of testers.

**Amendment - Moved that** the motion be amended as follows: Replace the word "must" in 2.4.9.1 b) with the word "shall".

### c) Explanation:

This brings the definition of a Junior shooter into line with that in all other areas of the Constitution and Rules.

Veteran Teams are now included in the Inter-Island format so also should be included in the International Matches.

# 1.9. <u>Executive Remit 9</u> Indoor Rules 2.5 – Target Standards

# a) Existing rule:

2.5.1 Targets recognized by TSNZ for Indoor competition shall comply with Specification in Section 2, APPENDIX F.

### b) To be replaced with:

2.5.1 PAPER targets recognised by TSNZ for Indoor competition shall comply with Specification in Section 2, APPENDIX F.
 2.5.2 ELECTRONIC targets recognised by TSNZ for Indoor competition shall comply with Specification in Section 2, APPENDIX G.

### Plus new Appendix:

Section 2, APPENDIX G

For competitions fired on electronic targets the equipment shall comprise:

a) Hardware which must be:

i) of any make and model approved by the ISSF which has Phase 1 approval, and

ii) approved by and registered with TSNZ in advance. TSNZ reserves the right to have such equipment inspected and tested for accuracy at any time it deems fit;

AND

b) Software which must be:

i) originally supplied with the hardware, or

ii) supplied to TSNZ specifications and installed subsequently with the approval of the hardware manufacturer, and

iii) which has not been altered by any unauthorised person.

### c) Explanation:

Changes are needed to allow and control the future use of Electronic Targets in Indoor shooting.

# 1.10. <u>Executive Remit 10</u> Indoor Rules 2.8 – Scoring Procedures

# a) Existing rule:

2.8.1 Scoring shall be carried out by two people, appointed by the local Association, working together, one of whom shall mark and the other who shall check mark. Check marking shall include confirming the value of any shot that is tested and confirming the total score for the target.

2.8.2 For targets specified in Rule 2.5.1 the value of the shot (except for an inner ten where rule 2.8.6 will apply) shall be decided by the edge of the shot hole furthest from the centre of the target as determined by a certified wide flange gauge. When the flange of the gauge touches the outside of the scoring line (ie, the intent, ignoring printing imperfections, of the white line is not visible) the lower value shall be credited. Testing for a value 5 shot, a certified plug gauge shall be used, marking the outside of the line. A shot touching the aiming mark, using a plug gauge, shall be scored as 4. It is only these two shots that are to be tested with a plug gauge. Any shot wholly outside the aiming mark shall have no score value.

- plus following clauses 2.8.3 - 2.8.8

### b) To be replaced with:

# 2.8.1 For PAPER TARGETS specified in Rule 2.5.1:

2.8.1.1 Scoring shall be carried out by two people, appointed by the local Association, working together, one of whom shall mark and the other who shall check mark. Check marking shall include confirming the value of any shot that is tested and confirming the total score for the target.

2.8.1.2 The value of the shot (except for an inner ten where rule 2.8.6 will apply) shall be decided by the edge of the shot hole furthest from the centre of the target as determined by a certified wide flange gauge. When the flange of the gauge touches the outside of the scoring line (ie, the intent, ignoring printing imperfections, of the white line is not visible) the lower

value shall be credited. Testing for a value 5 shot, a certified plug gauge shall be used, marking the outside of the line. A shot touching the aiming mark, using a plug gauge, shall be scored as 4. It is only these two shots that are to be tested with a plug gauge. Any shot wholly outside the aiming mark shall have no score value.

2.8.3 – 2.8.8 – plus change to numbering of the 2.8.1 subsection as 2.8.1.3 – 2.8.1.8.

### 2.8.2 For ELECTRONIC TARGETS specified in Rule 2.5.2:

- 2.8.2.1 Scoring printouts must be printed for all matches shot on electronic targets.
- 2.8.2.2 All scoring printouts shall be checked by a person appointed by the local Association.
- 2.8.2.3 The value of a shot may not be challenged; the value of all shots as printed on the scoring printout shall be final.

2.8.2.4 SCORING PENALITES - The following scoring penalties and irregularities shall apply in all competition:

2.8.2.4.1 **TOO MANY SIGHTING SHOTS** – if there are more than the maximum of three permitted sighting shots on a completed match printout and

a) the total number of shots, including sighting shots, is not more than 13 (100 possible) or 23 (200 possible), then the three highest valued shots on the sighting diagram shall be discounted and the remainder shall be treated as counting shots. A penalty deduction of one point for each excess shot fired on the sighting diagram shall be imposed.

b) the total number of shots, including sighting shots, exceeds 13 (100 possible) or 23 (200 possible), then the three highest valued shots on the sighting diagram shall be discounted and the remainder shall be treated as counting shots and Rule 2.8.1.7.3 shall apply.

### 2.8.2.4.2 **TOO FEW SIGHTING SHOTS** – Should a completed match printout have

a) only one sighting shot then the highest counting shot shall be regarded as a sighting shot and discounted.

b) no sighting shots, then the two highest counting shots shall be regarded as sighting shots and discounted. Failure to notify the Range Officer before commencing counting shots will deem the shooter to have fired the number of sighting shots that appear on the match printout.

2.8.2.4.3 **CROSSFIRES** - Any competitor who fires on a target other than their allocated target shall be penalised two points per crossfire. Where the actual firers of the scoring shots cannot be determined on a target which has been cross fired on, the competitor receiving the shot shall be credited with the higher value shot. If the actual firers of the shots on the overloaded diagram can be determined, then each competitor shall be credited with the value of the shots fired. The competitor who crossfires shall be penalised two points for each shot crossfired. Any competitor who fires on to the target of another competitor, or fires a shot which for any reason does not register on any target, and then fires the full number of shots allowed for the competition, shall be disqualified and reported to the Range Committee for further disciplinary action.

### c) Explanation:

Changes are needed to allow and control the future use of Electronic Targets in Indoor shooting.

**Discussion:** Wellington, East Otago, Graeme Hudson, Marlborough, Manawatu, North Otago – regarding "certified" gauges should be "TSNZ-approved", fairness compared to paper targets, one or multiple aiming points, importance of permitting use of electronic targets and adjusting in future if needed.

# 1.11. <u>Executive Remit 11:</u> Indoor Rules 2.11.9 – Sighting Shots

# a) Existing rule:

2.11.9 SIGHTING SHOTS

2.11.9.1 Two compulsory shots and one additional optional sighting shot shall be permitted on the designated sighting diagram, prior to the commencement of counting shots (see Rule 2.8.7.2).

2.11.9.2 The sighting diagram shall be the centre diagram on an eleven-diagram target. Where multiple targets are used, all

but one of the sighting diagrams shall be defaced in a manner that can be seen by the naked eye from the firing point.

2.11.9.3 In twenty-shot matches the two targets shall be placed adjacent, horizontally, on the target frames.

### b) To be replaced with:

2.11.9 SIGHTING SHOTS - Two compulsory shots and one additional optional sighting shot shall be permitted prior to the commencement of counting shots.

2.11.9.2 For PAPER targets:

a) the sighting diagram shall be the centre diagram on an eleven-diagram target.

b) where multiple targets are used, all but one of the sighting diagrams shall be defaced in a manner that can be seen by the naked eye from the firing point.

b) in twenty-shot matches the two targets shall be placed adjacent, horizontally, on the target frames.

### 2.11.9.3 For ELECTRONIC targets:

a) all sighting shots must be fired with the target control system in "Sighting" mode.

b) it is the shooter's responsibility to change to from "Sighting" mode to "Match/Competition" mode before firing any counting shots.

### c) Explanation:

Changes are needed to allow and control the future use of Electronic Targets in Indoor shooting.

### 1.12. <u>Executive Remit 12:</u> Indoor Rules 2.11.11 – Malfunctions

#### a) Existing rule:

2.11.11.1 Where a rifle or accessory develops a mechanical malfunction that prevents the competitor from completing a target, the competitor shall be permitted to complete the target in a later detail or squad, once the fault has been rectified. The competitor may also elect to use a substitute rifle or accessory.

2.11.11.2 The only defective cartridge that shall be recognized is one where the projectile does not leave the muzzle end of the barrel. Once the blockage has been cleared another cartridge may be used and the shoot completed in accordance with Rule 2.11.11.4. Where a projectile leaves the muzzle end of the barrel and for any reason whatsoever does not hit any target, the competitor shall lose the shot.

2.11.11.3 If a shoot cannot be completed within the allotted time for any reason outside the competitor's control, other than the provisions set out in Rules 2.11.11.1 or 2.11.11.2, the competitor shall have the right to claim completion of the shoot in accordance with Rule 2.11.11.4.

2.11.11.4 Where a competitor elects to complete a shoot under Rules 2.11.11.1 or 2.11.11.2 or 2.11.11.3, one sighting shot plus time equivalent to one minute per counting shot remaining shall be allowed to complete the target.

### b) To now include:

2.11.11.3 Where an electronic target malfunctions, the shooter shall be permitted to complete the target in a later detail or squad and the shoot completed in accordance with Rule 2.11.11.5.

(Note: Original 2.11.11.3 and 2.11.11.4 are then renumbered to .4 and .5)

#### c) Explanation:

Changes are needed to allow and control the future use of Electronic Targets in Indoor shooting.

**Discussion**: Marlborough, East Otago, Graeme Hudson, North Otago, Hutt Valley, Denva Wren, Wanganui, Ellesmere – regarding rule numbering, types of malfunctions, appropriate time to complete, number of extra sighters, UK equivalent rules, Range Officer's responsibilities, difficulties overriding electronic target usage, Indoor Committee input useful.

# 1.13. <u>Executive Remit 13:</u> Indoor Rules 2.12 – Postal Competitions

### a) Existing rule – Duties of witnesses:

2.12.9.2.4 To sign and date each target after it has been shot. For an Association Teams event a signed certificate verifying the targets en bloc shall suffice;

### b) To be replaced with:

2.12.9.2.4 To sign and date each paper target or electronic scoring printout after the match has been shot. For an Association Teams event a signed certificate verifying the targets and printouts en bloc shall suffice;

PLUS

#### a) Existing rules:

2.12.10 Targets shall be returned, after shooting, to the local Association for scoring, not later than the date specified in the annual advertisement. Directly Affiliated Clubs shall return shot and witnessed targets to the Administration Officer, for marking, by that same date.

2.12.11 Any target received in a mutilated condition shall be disqualified.

2.12.12 The local Association authorised markers shall score targets in accordance with the rules for scoring. Certified gauges shall be used for scoring. It is the responsibility of the local Association to provide certified gauges.

2.12.13 The local Association shall verify the correct score has been entered on the results form and forward the scores to the Administration Officer by the date specified in the annual advertisement and shall hold shot competition targets until the final results are distributed. 4.11.2 TSNZ ISSF Medals shall be awarded by TSNZ for the New Zealand Championship ISSF events at the National Air Rifle Championships according to the current ISSF Rules.

4.11.4 ISSF medals and TSNZ certificates shall not be awarded where the competition is uncontested (i.e. where there is only one entrant).

### b) To be replaced with:

4.11.2 TSNZ Medals shall be awarded by TSNZ for the New Zealand Championship events at the National Air Rifle Championships according to the current TSNZ Trophy Steward Guidelines.

4.11.4 TSNZ Medals and certificates shall not be awarded where the competition is uncontested (i.e. where there is only one entrant).

### c) Explanation:

- 1. These matches held at the TSNZ Nationals are the pinnacle of the Air Rifle shooting season and winners are truly NZ National Champions, so the change in title is to reflect this properly.
- 2. As these become TSNZ matches and not ISSF ones, it is TSNZ guidelines which should be followed for medal presentations.

# 1.28. <u>Waikato Remit 1:</u> Indoor Rules 2.2.13 – Hearing protection

### a) Current ruling:

2.2.13: All competitors, officials and other people in the immediate vicinity of the firing point are urged to wear earplugs, earmuffs or similar hearing protection.

#### b) Revised ruling:

All competitors, officials and other people in the immediate vicinity of the firing point must wear earplugs or earmuffs for hearing protection during live firing.

# c) Explanation:

The current rule puts the onus on individual clubs to enforce safety and is open to interpretation e.g. hands over the ears does not provide adequate protection to the eardrum. Hearing protection in a sport that undoubtedly causes significant damage to the ear drum should be mandatory not optional.

**Discussion:** Wellington, East Otago, Marlborough, Ashburton, Ellesmere, Southland, Taranaki, Graeme Hudson, Wanganui, North Otago, Christchurch, Mid Canterbury, Waikato, Ashley, Manawatu – regarding definition of immediate vicinity, range standing orders, temporary ranges, individual choice, Health & Safety legislation, practicality, penalties for non-compliance, dispensations, age limits if juniors only, difficulties in policing, importance of protecting hearing particularly in youth.

**Amendment - Moved that** the motion be amended as follows: to become "All competitors, officials and other people aged under 18 in the immediate vicinity....."

All competitors, officials and other people in the immediate vicinity of the firing point must wear earplugs or earmuffs for hearing protection during live firing.

### c) Explanation:

Will be the same as above as it is noted that in air rifle rules only the competitors are required to have hearing protection – again hearing protection should be compulsory for all within the vicinity of the firing point.

# At the request of Waikato and with the unanimous agreement of the meeting Waikato Remit 2 was withdrawn as the 2/3 majority required was unlikely following voting on Waikato Remit 1.

# 12.30. Waikato Remit 3: Outdoor Rules 3.2.16 - Hearing protection

#### a) Current ruling:

3.2.16: All competitors and other people in the immediate vicinity of the firing point are urged to wear earplugs, earmuffs or similar hearing protection

### b) Revised ruling:

All competitors, officials and other people in the immediate vicinity of the firing point must wear earplugs or earmuffs for hearing protection during live firing.

#### c) **Explanation**:

Will be the same as the above only it is noted in the outdoor rules that competitors and others are required to wear hearing protection but not range officials. By making the use of hearing protection mandatory we are giving coaches and range officers the authority to insist on no detail starting until the minimum safety standards are in place. Just like the flags it will only take a short time for people to get used to it. Non-compliance would mean being barred from entry to the firing area during live firing.

Waikato requested that Waikato Remit 3 be withdrawn as the 2/3 majority required was unlikely following voting on Waikato Remit 1. Unanimous agreement by the meeting was NOT obtained.

**Amendment - Moved that** the motion be amended as follows: to become "All competitors, officials and other people in the immediate vicinity of the firing point are urged to wear earplugs or earmuffs for hearing

protection during live firing. All Junior competitors must wear earplugs or earmuffs for hearing protection during live firing"

# 13. BUSINESS FOR WHICH NOTICE HAS BEEN GIVEN:

### 13.1. Association Championships - Remit submitted by Hutt Valley:

### Current Rule

No Existing Rule, insert new rules:

### Section 2 Appendix VI - Association Championships

- This competition shall consist of two parts
- Part 1 will be a graded Championship
- Part 2 will be an open Championship
- These 2 parts shall be treated as separate matches and score not to be aggregated

### **Explanation**

In past decades, the membership was greater than the membership present day. Also the level of scores were much closer, often competitors were only separated by a point of a point going into the final, because of target degree of difficulty, and marking.

These days' things are very different, margins are broader. Realistically only top two or three have a chance of winning an aggregated championship, and the rest spend approx. \$10 with little or no hope of winning. Primarily championships are being used for seeding purposes, and often open championships not being shot for by people who have earned their spot in the final. Increasingly competitors are not saying behind for this event.

Some are running these as separate matches, some are not, some are running with shooters who earn their place in the final, some are not, If we want to encourage participation, make it interesting and put some seriousness into the competition, in the Open Championships I would like to suggest we do this in the same format as an ISSF outdoor event, except the elimination for the moment, in the future, electronic targets may make this possible.

At the Executive Meeting on 28<sup>th</sup> July the above Remit on Association Championships, submitted by Hutt Valley Association for the 2017 AGM, was declined by the Executive as a valid remit, and therefore is put forward at the AGM as a matter of *Business for Which Notice Has Been Given*. The reason the Remit was declined is that the running of Association Championships is a matter for each individual Association. TSNZ currently does not have any direct jurisdiction over the running of Association events within the Constitution, and the Executive considers that this is appropriate.

**Discussion:** Southern Hawkes Bay, Manawatu, East Otago, Waikato, Hutt Valley, Mid Canterbury – regarding current practice, using Final Scores for North vs South Selection, benefits of shoulder to shoulder finals, Associations wanting to run their own events.

The meeting agreed that this is not an Executive responsibility and that Associations wish to continue to run their own Championships as they see fit. No further action required.

# 13.2. Indoor Committee – discussion led by Executive:

In September 2016 the TSNZ Outdoor Committee was launched as a result of TSNZ's goal of increasing participation in 50m Prone, 3P, Air Rifle and Benchrest - the "Outdoor" disciplines. Their key aims were:

- 1. To grow participation and membership in Outdoor Shooting in NZ;
- 2. To encourage entry in the 2017 Outdoor Nationals;
- 3. To review the 2017 Outdoor Nationals shortened programme following that event, and make recommendations for the future.

The Executive has been asked why there is no comparable Indoor Committee, so in July 2017 TSNZ members were asked via the email newsletter INSIGHTS if there was anyone interested in forming such a committee. No replies were received.

The Executive now seeks discussion at the AGM as to whether Members see an Indoor Committee as a need, and if so, what direction this committee should follow.

**Discussion:** Hawkes Bay, Marlborough, East Otago, Mid Canterbury, North Otago, Manawatu – regarding technical committee for electronic targets, publicising in INSIGHTS again, subjects to be covered (Benchrest, school shooters, marketing).

**The meeting agreed** that an Indoor Committee should be formed. Three volunteers were accepted from the floor: Nick Phillips (East Otago), Bryan Hunter (Mid Canterbury), Neil Kinsey (Wellington). To now be publicised in INSIGHTS, asking for more members.

### 13.3. Electronic targets – discussion led by Executive:

There are currently three manufacturers of Electronic Targets which comply with the technical requirements in the newly submitted remits for Indoor Rules: Megalink, Meyton, and Sius. While the three systems all technically comply, they do have some differences in setup, and so are not compatible with each other in regards to real-time or online data sharing. The Executive wishes to encourage the installation of electronic targets in ranges wherever possible, and is aware that Clubs and Associations may be waiting for guidance before purchasing.

The Executive now seeks discussion at the AGM as to whether Members see difficulties with real-time or online data sharing as a disadvantage that should be avoided, or alternatively, whether having different non-compatible systems in ranges throughout NZ is not a significant issue, leaving each Club/Association the ability to install whichever system they prefer.

The meeting agreed that this topic was best to be considered by the new Indoor Committee. No further action required.

### 14. BUDGET 2017-18

The 2017-18 Budget was presented by Denva Wren.

**Discussion:** Graeme Hudson – regarding details of Trading Contract, NSZF funding, proposed renegotiation of Administration Contract.

The meeting agreed that details of Trading and Administration Contracts should correctly remain with the Executive to decide.

Moved that the Budget for 2017 - 2018 be adopted.
