Application for a B709 Police Confirmation for an Individual or for a Business - Non Dealer.

This form should be used by an Individual or Business (non-dealer) making application for a police confirmation and certification for importation of firearms, paintball guns, firearms parts, ammunition or weapons. The B709 Certification will only be issued where the applicant is authorised to possess the article/item in NSW by a firearms licence or permit or where no such authorisation is required. This form must be accompanied by the relevant form for the item being imported; ABC firearms & parts, H firearms & parts, paintball guns & parts, ammunition or weapons. Fields bordered in RED are mandatory. This form is interactive and may be completed electronically, printed and emailed to imports@police.nsw.gov.au, faxed to 0266709811 or posted to:
